Definition of Student Ragging

Ragging refers to any act of **abuse, harassment, or humiliation** carried out by one or more students (typically seniors) on other students (usually juniors) in educational institutions. It can be **verbal, physical, emotional, or sexual** in nature.

As per UGC (University Grants Commission), ragging is:

"Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student; indulging in rowdy or undisciplined activities that cause or are likely to cause annoyance, hardship, or psychological harm to a student."

Punishable Acts of Ragging

The following activities are considered punishable forms of ragging:

1. **Verbal Abuse:**
 - Teasing, mocking, or threatening
 - Use of foul language or slurs
2. **Physical Abuse:**
 - Beating, hitting, or causing bodily harm
 - Forcing students to do physical tasks (e.g., sit-ups, crawling)
3. **Psychological Harassment:**
 - Intimidation or threats
 - Forcing students into degrading or embarrassing acts
4. **Sexual Abuse:**
 - Inappropriate touching or comments
 - Forcing students to strip or perform sexual acts
5. **Forcing Substance Use:**
 - Forcing someone to consume alcohol, drugs, or any intoxicants
6. **Social Exclusion:**
 - Isolating or denying participation in group activities
7. **Cyber Ragging:**
 - Online bullying, sharing morphed photos, or harassing via social media
8. **Any act that causes mental trauma or physical harm** to a student

Punishment Against Ragging

Under the **UGC Regulations (2009)** and various state laws, ragging is a **criminal offense** in India and can attract **severe penalties**, including:

Institutional Punishments:

- Suspension or expulsion from the college/university
- Withholding of scholarships or other benefits
- Debarring from exams or placement opportunities
- Cancellation of admission

Legal Punishments:

- **Filing of FIR (First Information Report)**
- **Imprisonment** (up to 3 years or more depending on the severity)
- **Fine** (Rs. 25,000 to Rs. 50,000 or more)
- **Criminal record**, which affects future employment and education
